

Bartington Instruments Website Terms of Use

Thanks for your interest in Bartington Instruments. This page sets out the terms and conditions on which we provide our users with access our websites at www.bartington.com, www.bartingtonshop.com, and www.bartingtondownloads.com (each of which we will refer to as our **Site**) and the content on our Site. **By using our Site, you are agreeing to these Terms of Use.**

In addition to these Terms of Use, our Privacy Notice describes the personal data which we may collect from users of our Site, and from other individuals with whom we deal, and explains how we may use it. It also describes how our Site makes use of cookies.

1. Who We Are

- 1.1 **We and us** means Bartington Instruments Ltd, a limited company registered in the United Kingdom under registration number 01938710 whose registered office address is at 10 Thorney Leys Business Park, Oxfordshire, England OX28 4GG.

2. Your Obligations
